## ANNOUNCEMENT

### SCHEDULE AND PROCEDURE INTERIM DIVIDEND PAYMENT PT EASTPARC HOTEL Tbk

Sesuai dengan keputusan Rapat Direksi PT Eastparc Hotel Tbk ("Perseroan") yang tertuang dalam Surat Keputusan Direksi Perseroan Nomor 0003/PT.EPH-Tbk/DIR-SK/V/2024 tanggal 21 Mei 2024, maka bersama dengan ini Perseroan mengumumkan kepada para Pemegang Saham Perseroan bahwa Direksi dan Dewan Komisaris Perseroan telah memutuskan untuk melaksanakan pembagian dividen interim tahun buku 2024 sebesar **Rp1,5** (satu koma lima rupiah) per lembar saham yang dibagikan kepada para pemegang saham yang berhak. Adapun jadwal dan tata cara pembayaran dividen tunai tersebut adalah sebagai berikut:

*In accordance with the decision of the Meeting of the Board of Directors of PT Eastparc Hotel Tbk (the "Company") as stated in the Decree of the Board of Directors of the Company Number 0003/PT.EPH-Tbk/DIR-SK/V/2024 dated May 21, 2024, the Company hereby announces to all stakeholders Shareholders of the Company that the Board of Directors and Board of Commissioners of the Company have decided to distribute an interim dividend for the 2024 financial year of **IDR 1.5** (one point five rupiah) per share which is distributed to the entitled shareholders. The schedule and procedure for the payment of cash dividends are as follows:*

## Tata Cara Pembagian Dividen:

1. Dividen Tunai tersebut akan dibagikan kepada para Pemegang Saham yang namanya tercatat dalam Daftar Pemegang Saham Perseroan (*recording date*) pada tanggal **6 Juni 2024** sampai dengan pukul 16.00 WIB.
2. Bagi pemegang saham yang sahamnya dimasukan dalam penitipan kolektif KSEI, pembayaran dividen interim akan dilaksanakan melalui KSEI dan akan didistribusikan pada tanggal **20 Juni 2024** ke dalam Rekening Dana Nasabah (RDN) pada Perusahaan Efek dan atau Bank Kustodian dimana Pemegang Saham membuka sub rekening efek. Sedangkan bagi pemegang saham Perseroan yang sahamnya tidak dimasukkan dalam penitipan kolektif KSEI maka pembayaran dividen Interim akan ditransfer ke rekening pemegang saham Perseroan.
3. Dividen interim tersebut akan dikenakan pajak sesuai dengan peraturan perundang-undangan perpajakan yang berlaku. Jumlah pajak yang akan dikenakan akan menjadi tanggungan pemegang saham Perseroan yang bersangkutan serta dipotong dari jumlah dividen Interim yang menjadi hak pemegang saham Perseroan yang bersangkutan.
4. Bagi pemegang saham yang merupakan Wajib Pajak Dalam Negeri (WPDN) berbentuk badan hukum, yang belum menyerahkan Nomor Pokok Wajib Pajak (NPWP) kepada Perusahaan Efek atau Bank Kustodian dimana pemegang saham

## Dividend Distribution Procedure:

1. *The Cash Dividend will be distributed to Shareholders whose names are recorded in the Company's Register of Shareholders (recording date) on **June 6, 2024** until 16.00 WIB.*
2. *For shareholders whose shares are deposited in KSEI's collective custody, the payment of interim dividends will be made through KSEI and will be distributed on **June 20, 2023** into the Customer Fund Account (RDN) at the Securities Company and/or Custodian Bank where the Shareholders open securities sub-accounts. As for the shareholders of the Company whose shares are not deposited in the collective custody of KSEI, the payment of the Interim dividend will be transferred to the account of the shareholders of the Company.*
3. *The interim dividend will be taxed in accordance with the applicable tax laws and regulations. The amount of tax that will be charged will be borne by the shareholders of the Company concerned and deducted from the amount of Interim dividends that become the rights of the shareholders of the Company concerned.*
4. *Shareholders who are Domestic Taxpayers (WPDN) in the form of legal entities, who have not submitted their Taxpayer Identification Number (NPWP) to the Securities Company or Custodian Bank where the shareholders have opened*

5. Bagi Pemegang Saham yang merupakan Wajib Pajak Luar Negeri yang pemotongan pajaknya akan menggunakan tarif berdasarkan Persetujuan Penghindaran Pajak Berganda ("P3B") wajib memenuhi persyaratan Peraturan Direktur Jenderal Pajak No. PER-25/PJ/2018 tentang Tata Cara Penerapan Persetujuan Penghindaran Pajak Berganda serta menyampaikan dokumen bukti rekam atau tanda terima DGT/SKD yang telah diunggah ke laman Direktorat Jenderal Pajak kepada KSEI atau BAE sesuai peraturan dan ketentuan KSEI, tanpa adanya dokumen dimaksud, dividen yang dibayarkan akan dikenakan PPh Pasal 26 sebesar 20%.
6. Bagi Pemegang Saham yang sahamnya dalam penitipan kolektif KSEI, bukti pemotongan pajak dividen dapat diambil di Perusahaan Efek dan/atau Bank Kustodian dimana Pemegang Saham membuka sub rekening efek dan bagi Pemegang Saham Warkat diambil di Biro Administrasi Efek Perseroan (BAE) dengan alamat sebagai berikut:

*securities accounts, are required to submit their NPWP to KSEI through the Securities Company or Custodian Bank. where shareholders open securities accounts, no later than **June 6, 2024** at 16.00 WIB.*

5. *Shareholders who are Overseas Taxpayers whose tax withholding will use a rate based on the Double Taxation Avoidance Agreement ("P3B") must comply with the requirements of the Director General of Taxes Regulation No. PER-25/PJ/2018 concerning Procedures for the Application of Double Taxation Avoidance Agreement and submitting a document of proof of record or receipt of DGT/SKD that has been uploaded to the website of the Directorate General of Taxes to KSEI or BAE in accordance with the rules and regulations of KSEI, without the said document, dividends The amount paid will be subject to Article 26 Income Tax of 20%.*
6. *For Shareholders whose shares are in the collective custody of KSEI, proof of dividend tax withholding can be collected at the Securities Company and/or Custodian Bank where the Shareholders open a sub-account and for Clearing Shareholders it can be collected at the Company's Securities Administration Bureau (BAE) at the following address:*
